












SKM provides down-the-hole drilling of blast holes in open pit operations. SKM has the equipment and personnel to drill in both hard (platinum, manganese, iron ore) and soft rock (coal) operations. Our production teams are supported by an engineering team comprising engineers, technicians and artisans with proven experience in maintaining and repairing the leading equipment brands. SKM has a strategic partnership with Sandvik Mining, a Tier 1 original equipment manufacturer of surface and underground trackless mining machinery from Finland, that ensures comprehensive after-sales support.

2M Logistics provides coal haulage and logistics services both on and off the mine.

The Industrial Development Corporation (IDC) is our funding partner and we also collaborate with Overlooked Group which is a diversified black-owned and operated mining group with underground and open-cast mining operations. Through these partnerships/collaborations, we are able to respond and support our client's needs.



Sedibelo Marketing & Trading supplies hard commodities and related solutions to the industrial sector. We supply over 30 000 tons of sized coal to the industrial sector every month. A key market segment is the cement industry, of which Lafarge Cement and AfriSam Cement are major clients.

Sedibelo Marketing & Trading has established itself as a reliable and trusted supplier of choice for quality coal in the cement industry and is steadily growing its coal supply market base to other industries. We are expanding our product range to include the marketing of copper, gypsum and scrap metals (aluminum, zinc).





Sedibelo Technologies develops and maintains bespoke technology solutions for the group. Our team has developed a mining solution around health and safety and engineering maintenance. Although the solution was specifically developed to streamline operational efficiencies within our group of companies, it has proven to be a solution that we are currently packaging into a commercial product.

Sedibelo Technologies owns 51% of MOADE Education Software, a software solutions company that has designed and developed SchoolLMS, an e-learning software platform for schools and higher learning institutions. The software is supported by the Centre for Public Service and Innovation (CPSI), and through this partnership the software is being piloted in eight schools across South Africa. We intend to market this suite of products in the country and beyond.
